

Agreement between Dark Valley of the Black Spire, Inc. and its Sponsored Lands

Independent Lands:

- Are located outside 150 mile radius of Portland, OR
- Must retain a contract with the Burning Lands Board of Directors
- Must abide by the Corpora, Amtgard Handbook on the Rules of Play, and IRCA rulings
- Retain all of their own funds
- Do not vote in BS elections or Althings, except regarding Althing issues which affect them directly.
- Are not subject to BS Althing rulings, except regarding issues upon which they have voting privileges
- Retain voting privileges with BS regarding IRCA clarifications
- Use their own set of relics listed in the Amtgard Handbook on the Rules of Play
- Will send proof of their attendance records once per six months to the Prime Minister of BS
- Will be reviewed each year to verify or adjust status of Land "Title" (Shire, Barony, Duchy), based on attendance levels and time in contact with BS and Burning Lands Board's of Directors
- Are entitled to use of the BS non-profit numbers for requests deemed reasonable by the BS Board of Directors
- Will only have kingdom events scheduled in their lands by mutual agreement of the Land Monarch and the BS Monarch and Prime Minister.
- Are eligible to receive awards from Kingdom level which smaller lands cannot issue

Dependent Lands:

- Are located inside 150 mile radius of Portland, OR
- Must retain a contract with the Burning Lands Board of Directors
- Must abide by the Corpora, Amtgard Handbook on the Rules of Play, and IRCA rulings
- Send 33 % of their "dues" to the kingdom level account
- Retain voting privileges in BS elections and Althings
- Are subject to BS Althing rulings
- Retain voting privileges with BS regarding IRCA clarifications
- May not use their own set of relics listed in the Amtgard Handbook on the Rules of Play, but may use one "Land Level" relic of their own creation, if desired
- Will send proof of their attendance records monthly to the Prime Minister of BS
- Will be reviewed each year to verify or adjust status of Land "Title" (Shire, Barony, Duchy), based on attendance levels and time in contact with BS and Burning Lands Board's of Directors
- Are entitled to use of the BS non-profit numbers for requests deemed reasonable by the BS Board of Directors
- Will have kingdom events scheduled in their lands by the BS Monarch and Prime Minister
- Are eligible to receive awards from Kingdom level which smaller lands cannot issue
